# COTTONWOOD HEIGHTS PARKS AND RECREATION SERVICE AREA POLICY GOVERNING

#### USE OF THE FACILITIES BY PRESENT AND PAST TRUSTEES

## **REFERENCE:**

Approved by the Board of Trustees; Revised April 19, 2014; Revised April 20, 2016

#### **PURPOSE:**

To provide clarification of Service Area privileges for past and present elected or appointed Board of Trustee members; adhering to all legislative laws governing total compensation limits and regulations set forth for an elected official of a service area (Utah Code 17B-1-307).

#### I. DEFINITIONS

CHPRSA: Cottonwood Heights Parks and Recreation Service Area

Present Trustee: A resident of CHPRSA, elected by residents of CHPRSA or appointed to serve an unexpired term by the Board of Trustees, to oversee the physical and financial operations of CHPRSA.

Past Trustee: An elected or appointed Board of Trustee member for CHPRSA that has honorably completed their term.

#### II. PRESENT TRUSTEE POLICY

1.0 Present Trustees of CHPRSA will receive a compensation amount set by the Board of Trustees, adhering to all legislative laws governing total compensation limits and regulations set forth for an elected official of a Service Area; adhering to all legislative laws governing total compensation limits and regulations set forth for an elected official of a service area (Utah Code 17B-1-307).

#### III. PAST TRUSTEE POLICY

- 1.0 Ultimate Membership
  - 1.1 Each Past Trustee and their spouse receive a life time ultimate membership. Family members listed on the membership, per the guidelines of CHPRSA, are eligible for ultimate membership benefits.

#### 2.0 Discounts

2.1 Past Trustees qualify for the same discounts on facility lessons/programs that are available to benefitted employees, as detailed in the Service Area's Personnel Policies and Procedures Manual, Section XIII, (Employee Use of the Service Area Facilities and Equipment) II .4.

# 3.0 Special Usage of the Facilities

- 3.1 Each Past Trustee may bring a group of 25 people to a regular public session at no charge, once per year, with a reservation.
- 3.2 Each Past Trustee will be entitled to two pavilion reservations per year, at no charge.
- 3.3 Other special usage of the facilities, during or after regular hours must be preapproved by the Director or designated representative. Use of the indoor pools and ice arena require special staffing, which must be arranged by the Service Area Administration. The outdoor pools are not available for special use.
- 3.4 The Past Trustee must accompany the group during usage of CHPRSA facilities.
